
CLOTHING BANK

ATTENDANCE GUIDE FOR PARENTS/CARERS

The law

Every child of compulsory school age has the legal right to an efficient, full-time education that is suitable to their age, aptitude, and any SEND they may have. Parents are legally required to make sure their child receives this education by attendance at school or by education otherwise than at school. Where a parent decides to register their child at school, there is an additional legal duty on them to ensure their child attends the school regularly – this means their child needs to attend every day the school is open, except in certain circumstances, e.g. the child is too ill to attend.

What YOU must do:

- ✓ Try to telephone the school before 8.30am <u>each day</u> of your child's absence.
- ✓ Tell the school in advance, of any medical appointments and bring in appointment cards/letters.
- ✓ If you are not sure whether your child is well enough to attend school, send them in anyway as they often perk up on arrival.
- ✓ Have a backup plan for if your child misses transport, call on a family member, neighbour or friend.
- ✓ If you and your child are experiencing difficulties with school attendance then talk to us as a first step so we can help!

What WE will do:

- Check your child's attendance every day.
- > Phone home to discuss your child's attendance with you.
- > Invite you into school for attendance meetings if we are concerned.
- > If we cannot establish a reason for absence, then we may make a welfare home visit.

Fixed penalty notices

Fixed penalty notices are served on parents where they have failed to ensure that their child of compulsory school age regularly attends the school where they are registered or at a place where alternative provision is provided. Fixed penalty notices can be used by all schools where the pupil's absence has not been authorised by the school and the absence constitutes an offence.

Fixed penalty Fines - Changes

The DFE have introduced some changes to the Penalty Notice fines with a particular difference being the new amounts payable. For all new offences where the start date of the absence is after the 19th August 2024, the fine will be payable at £160, (up from the previous amount of £120) if paid within 28 days and if paid within 21 days it will reduce to £80, (up from £60).

<u>Please note: NEW</u> - Parents meeting the requirements for a penalty notice will only be allowed to receive 2 penalty notices for a specific child in a rolling 3-year period. The second penalty notice in a 3-year period will only be payable at the higher rate of £160, there will be no option of a reduced amount. Should the parent meet the requirements for a 3rd time in 3 years then the authority will consider taking other legal interventions that are available, relative to the needs of the case.
